GENERAL TERMS & CONDITIONS 2020

- 1. Artificial Insemination (AI), Embryo Transfer (ET) & Foaling:** Mares taken at livery for AI, ET, OPU/ICSI and for foaling. It is Stud policy to scan all mares.
- 2. Equine Viral Arteritis (EVA) & Strangles:** All horses are required to be blood tested for EVA & strangles within the 28 days before arrival at Stud. Animals that have been vaccinated against strangles will require a guttural pouch washout before arriving at the stud. The tests should be sent to an approved laboratory and a copy of the results sent to the stud by post, email or fax in advance of the horse arriving.
- 3. CEM & EIA:** OPU mares are required to have a CEM swab and an EIA blood test before arrival at stud and before OPU can be carried out. **These tests must be sent to the APHA** and the results sent to the Stud. .
- 4. Equine Influenza/Tetanus:** All horses to have had an annual flu/tet vaccination booster before coming to stud or if not vaccinated must have had the primary flu/tet vaccination not less than 2 weeks before arrival at stud.
- 5. Booking Form:** All owners/agents are required to fill in and sign 'the stud' booking form when they bring their horse to stud. If the horse is sent with a third party the form must be completed and signed before the mare arrives. **No reproduction work will commence until the required forms are completed, signed and received in the stud office.**
- 6. Passports:** It is a legal requirement that horses are accompanied to the stud with their passport. For horses born after 1st July 2009 regulations require horse passports to be linked to a Microchip Identification; 'the Stud' offers a microchipping service. All horses under the care of the Stud should be signed out of the human food chain and section IX of the horse's passport should be signed by the owner. Alternatively, by agreeing to the Stud's terms the owner/agent agrees to the Stud signing it on their behalf. By signing the horse out of the food chain the owner is giving the Stud the freedom to use their clinical judgement in the use of medicines and the prescribing cascade. If the owner wishes for their horse to remain in the human food chain they must notify the Stud immediately in writing so that appropriate action can be taken.
- 7. In Foal Fee:** Applicable for all mares leaving the stud scanned in foal to fresh, chilled or frozen semen. The in foal fee includes insemination costs and all the handling associated with the veterinary work. If a mare leaves before her pregnancy scan it will be assumed that she is in foal and the fee will be payable before leaving the stud. If subsequently she is found to be not in foal before October 1st and confirmed by a vet's certificate, the 'in foal fee' will be returned.
- 8. Embryo Transfer:** Agreements must be signed and adhered to the conditions set out on the Recipient Mare Hire Agreement Form. Legal title to any embryo transfer undertaken by Twemlows Stud Farm shall remain the sole property of R L Matson & Son until all outstanding fees (together with interest if applicable) have been paid in full and cleared through the bank account. If the recipient mare loses the foal either prior to foaling or after for whatever reason, no refund of fees will be due. Full terms are listed on the Recipient Mare Hire Agreement form.
- 9. Stallion Stud Fees:** The mare owner is responsible for ensuring stud fees are paid in full.
- 10. Veterinary:** Assistance will be called in when deemed necessary by the Stud and the work will be carried out by the Stud's resident vet or by the supporting practice, Fyrnwy Equine Clinics; all costs will be charged direct to the owner. All vaccinations/blood tests/swabs carried out by the Stud are chargeable to the owner.
- 11. Payment.** All fees must be paid before the horse leaves the stud. We reserve the right to charge a deposit at the time of the horse's arrival, which will be deducted off the horses **final invoice**. Generally invoices will be raised on a calendar month basis and must be settled by the 15th of the following month unless the horse leaves prior to that date, in which case payment must be made prior to departure. "Fees" includes livery, veterinary work and other costs but not stallion fees. Owners who send a third party to collect their horse must make arrangements to pay in advance of collection. VAT is charged on all accounts. Payment may be made in cash or by debit or credit card or by bank transfer. Interest will be charged on outstanding amounts from the due date until the actual date of payment (as well as before judgement) at a rate of 4% per annum over base rate of NatWest Bank plc from time to time in force which shall accrue on a daily basis. Any invoice outstanding will be referred to a debt collecting company and will be subject to a surcharge to cover the costs incurred. This surcharge together with all other charges and legal fees incurred will be the responsibility of the owner and will be legally enforceable. Legal title to any embryo or foal resulting from an insemination or embryo transfer undertaken by Twemlows Stud Farm shall remain the sole property of R L Matson & Son t/a Twemlows Stud Farm until all outstanding fees together with interest if applicable, have been paid in full and cleared through the bank.
Horses will not be allowed to leave before payment is made in full.
- 12. Hind Shoes & Farrier:** Please ensure horses arrive at stud without hind shoes (an exception is made for horses being housed individually at the appropriate rate). All horses will have their feet trimmed when necessary and any costs charged to the owner's account. Any specific shoeing requirements must be notified to the Stud when the horse is booked in.
- 13. Insurance:** The Stud accepts no responsibility for visiting horses and does not carry insurance cover; it is the owner's responsibility to provide their own insurance cover.
- 14.** Horses whilst at Twemlows Stud Farm will receive every possible care, attention and supervision, but the Stud accepts no responsibility whatsoever for accident, theft or disease, nor does the Stud give any express or implied guarantee of success.
- 15.** All mares are AI / ET / OPU / ICSI / foaling are at their owner's risk and the Stud is not liable for any damages or compensation in respect of any injury or damage howsoever caused to any horse, including (but not limited to) that caused through AI / ET/ OPU / ICSI /foaling.
- 16.** Owners must accept that while their horse is at Twemlows Stud Farm it is at their risk - no responsibility for the animal and any belongings left at stud can be accepted by the Stud and all liability claims, damages, costs, loss and expense of any kind whatsoever are hereby expressly excluded.
- 17.** The Stud is not responsible for semen / oocytes / embryos supplied which are: incorrectly labelled, arrives with incorrect paper work or in an unsuitable condition upon arrival. Similarly the Stud is not responsible for the failure of semen / oocytes / embryos to arrive on time.
- 18.** Frozen semen / embryos stored at the Stud on behalf of stallion and mare owners are done so at their own risk and they are responsible for insurance thereof. The Stud reserves the right to charge for the storage of any frozen semen / embryos. Frozen semen / embryos may be removed from storage at any time on a date and time to be agreed with the Stud after giving seven days written notice provided that such removal is not in breach of any relevant statutory or regulatory requirement..
- 19.** The Stud reserves the right to refuse entry to the stud to any horse in the event that any of these conditions are not complied with or where they consider that horse to be an unacceptable health and safety risk or for any such reason.
